PRIMARY FUNCTION

- Support the preschool program to organize and support preschool programs and Speech and Language Pathologists (SLP).
- Support the Preschool Assessment Team process.
- Design professional learning.

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Serve as a primary resource for preschool speech/language programs.
- Provide support for the Preschool Assessment Team process and procedures.
- Develop and make recommendations regarding policies and procedures for preschool speech/language programs.
- Work collaboratively and/or independently to plan, design, and facilitate professional learning, which includes integrating technology and other support/resource materials.
- Coordinate and support compliance with special education procedures and guidelines.
- Act as Local Education Agency (LEA) representative at Part C Transition Planning Conferences (TPC).
- Act as Administrative Designee for preschool Individualized Education Plan (IEP) meetings.
- Attend staff meetings, trainings, conferences, and perform related activities as required or assigned.
- Provide support for preschool SLPs, including Clinical Fellowship Year supervision.
- Design, provide, and participate in in-service training to early childhood general and special education staff regarding development of young children's speech and language development, referral procedures, assessment, and services.
- Use technology proficiently to maintain online records and systems (e.g., Special Education Information System (SEIS), Filemaker, Excel, Google Suite, etc.).
- Represent the district with community agencies.
- Other essential job-related work as assigned.
- Work hours are consistent with normal District office hours up to an eight-hour day.

KNOWLEDGE AND ABILITIES

KNOWLEDGE OF:

- Knowledge of subject matter as evidenced by a Masters in Speech/Language Pathology.
- Special education laws, regulations, and procedures.
- Strong interpersonal skills and ability to work collaboratively with administrators as well as certificated and classified staff.

- Early childhood experience preferred.

- Establish and maintain cooperative and effective working relationships with others.
- Effectively communicate using strong oral and written communications skills.
- Demonstrate enthusiasm and interpersonal skills to relate well with preschool students, parents, staff, administration, and the community.
- Share ideas, information, and work collaboratively on a team.
- Maintain confidentiality and use discretion.
- Work with a diversity of individuals and/or groups.
- Maintain cooperative working relationships with parents, staff, outside agencies, and other school personnel.
- Maintain effective and timely written and oral communications with parents, staff, other school personnel, and contracted agencies.
- Consult with District staff to coordinate, plan, and deliver additional training for preschool staff.

- Utilize effective time management skills.
